Presentation

For some years now, the UOC has been involved in a process of growth and expansion. This is very good news indeed. Another piece of good news is that this growth has been taking place in very important areas within our universities: the quality of teaching, and the internationalisation of the academic offer - an internationalisation which is reflected both in the content of what is being taught and in the market to which this content is directed.

A good example of this is the international doctoral course in Catalan, Spanish and English. The UOC is launching it on the basis of our particularity as a distance university which uses the Network to communicate and to receive communication; but, in one way or another, this is the only way for any university aspiring to face the future decidedly and successfully.

This orientation and process take place – and need to take place – in collaboration with the other Catalonian universities, as the whole university system must end up being strengthened and enriched by this interdependence. And it is equally necessary for the UOC to be known everywhere. This expansion obviously enhances the reputation of the UOC, but it also affects the prestige of everything that – in higher education and in many other spheres – is produced in Catalonia.

The UOC has at all times been committed to quality and internationalisation. Universities, companies, and public and private institutions find in the UOC the right partner for their aims, and the UOC realises how positive the stages of its expansion have proved to be.

I am especially aware of everything that the UOC does in the field of international solidarity, which is the demonstration of what is done and the stimulus for what can be done in this sphere by a university using the new technologies. This is why the first beneficiaries of this awareness are the students who constitute the UOC, as they carry out this undertaking in the open and responsible environment which our times demand.



Elections of the commissions at the support centres

The Norms Concerning the
Organisation and Workings of the
UOC, approved by the Board of
Trustees of the Foundation for the
Universitat Oberta de Catalunya, and
ratified by the Government of the
Generalitat de Catalunya (Catalonian
Autonomous Government) by the
Decree of 1st April 1997, define the
matters relating to the participation of
the community in the workings of the
University, and the students'
representative bodies:

- the Campus Commission
- the Faculty Commissions
- the Support Centre Commissions

Elections to membership of the Support Centre Commissions were convoked by the Rector on 23rd March 2001, and the final results were published on 29th May of the same year.

The roll of candidates or voters in these elections included all students matriculated in any of the faculties of the recognised degrees of the first or second cycles. 47 candidates stood, to cover 39 of the 54 possible vacancies.

Voting was carried out by means of the mechanism prepared to this effect on the Virtual Campus. This mechanism allowed personal voting on the part of all students listed in the census and for the candidacies put forward at the support centres at which they were registered.

813 people voted, and these represented 5.03% of the electorate.


As a result of this year's reflection process on strategy, the Strategic Commission, the Management Operating Commission and, finally, the Programmes Commission were



The Virtual Campus

During the academic year 2000-2001, the Virtual Campus underwent a twofold evolution, which consisted in improvements made in its current service and the first steps in the development of a new system.

classrooms, the first systems for the classroom monitoring of students with new types of classroom were developed.

Face-to-face Meetings

Face-to-face meetings registered a stable attendance that neared 40% of the total number of students enrolled. Each presentation meeting mobilised some 8,000 people, and each synthesis meeting, 7,000 (data

Institutional Evaluation

Overall, the data resulting from the questionnaire on institutional evaluation continue to be positive in almost all the aspects which students, tutors and counsellors of the UOC are asked to evaluate.

In this regard, a special mention should be made of the importance attached to continuing evaluation (positive or very positive by 90.8% of students, 92.9% of tutors and 91.9% of counsellors).

Only in the use of some of the Campus facilities, like the services and centres spaces, we find results which are clearly very low (often or very often visited by 7.8% and 1.3%, respectively).

Other issues of interest, like the assessment made of the different aspects of subjects, and of the counsellor's and tutor's task, continue with the same positive trend as in other semesters and are awarded a value of 4 out of 5.

As for aspects which are singled out by its positive valuation, we find, among them, the novelties incorporated during the semester and specially the improvements relating to examinations:

- Incorporation of a third Saturday of examinations (94% very positive -positive)
- Calendar of examinations at the time of enrolment (90% very positive -positive)

The most frequented area of the Campus by students is *Student Care* (50.9% often or very often).

Finally, the mailboxes most highly valued by students were: in the first place, *Enrolment transactions* (71.2% thought it good or very good) and, in the second place, *Examinations transactions* (69.3% thought it good or very good). We therefore see that mailboxes providing answers at the times of greatest relevance for students, such as during enrolment and examination processes, obtain the highest recognition.

Job Vacancies Service

In December 2000, the UOC launched the new Virtual Job Vacancies Service.

267 companies interested in UOC students joined the scheme. A total of 925 offers were made, 1,764 students submitted their curricula, and 70% of them took part in selection processes. Finally, out of the total of UOC curricula inscribed in these selection processes, 60% of their authors were invited to interviews at the various companies.

Finally, a bronze medal was won in the kata category of karate.

Financial Report

Introduction

In the section that follows we are detailing the financial data of the Foundation for the Universitat Oberta de Catalunya corresponding to the fiscal year 2000.

As in previous years, the firm Bové Montero i Cia. audited the Foundation's yearly accounts and presented the relevant positive report to the Foundation's Board of Trustees, which approved the report in the session of 25tht June 2001.

After detailed analysis, we are singling out the most relevant aspects of the financial data as follows:

- The monitoring of the profit and loss sheet, and the investment sheet, for the fiscal year 2000 has been done separately for recognised studies (contract programme), for other training activities, and for IN3.
- In accordance with the forecasts, the ordinary budget for the fiscal year 2000 increased with respect to that of the previous fiscal year

by 35%, in order to cover the increase in activities.

- Investments totalled 792,893,550
 PTA. The most important item was destined to teaching modules and to computer applications, which represented 38% and 26%, respectively, of total investment for the fiscal year.
- The cash flow generated was 211,218,133 PTA, which was destined to the financing of investments without specific funding.



Balance Sheet Structure on 31st Dec. 2000










